The current legal blood alcohol limit in Georgia is .08% for adult drivers (persons ages 21 and over) who are NOT operating a commercial motor vehicle (CMV).

Use These Tips To Avoid Being A Drunk Driver At Any Time:

1. Have A Designated Driver

Always choose a non-drinking designated driver — every time you go out. You can also help identify a designated driver for someone else from your group.

2. Get A Ride

If you go out alone, do not drink alcohol or get a ride if you do. You can call a taxi or car-sharing service for a ride like Uber or Lyft.

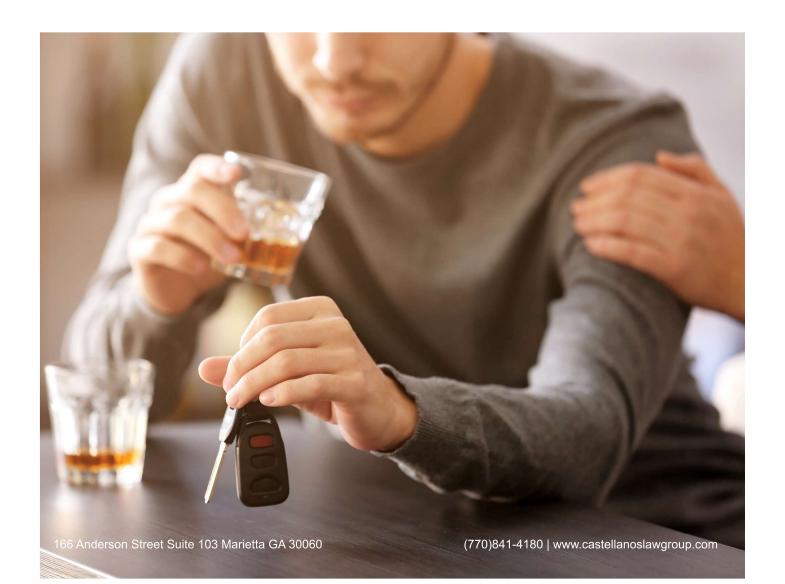


3. Host An Event

4. Help A Friend

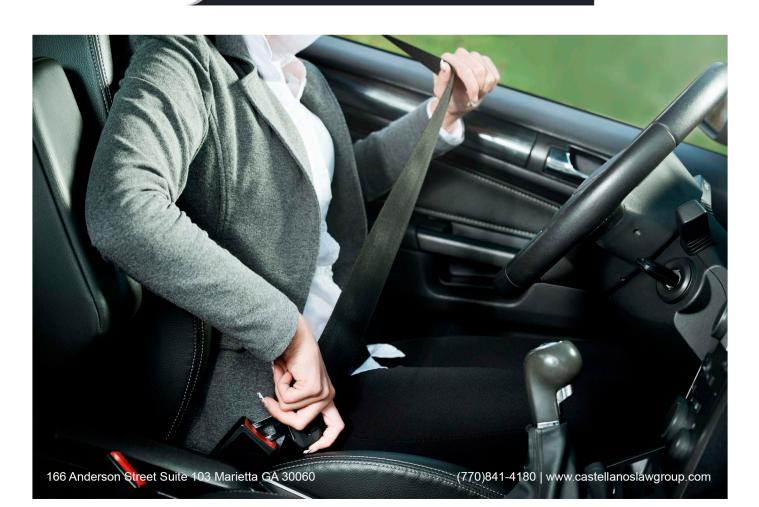
Do not let friends drive after drinking. If a friend has been drinking, it's always a good idea to take their keys and call a taxi or Uber/Lift. They will thank you later.
